

This report describes the judicial education training programs funded by grants from the Department of the Interior in fiscal year 2018 benefitting the judiciaries of the American territories and Freely Associated States in the Pacific. The report enables the Office of Insular Affairs of the Department of the Interior and the U.S. Congress to assess the performance of the Ninth Circuit Judicial Council Pacific Islands Committee relative to its mission and stewardship of the funds entrusted to it. About the Pacific Islands Committee

The Judicial Council of the Ninth Circuit established the Pacific Islands Committee to fulfill the oversight responsibilities of the Council and of the Judicial Conference of the United States with respect to the judiciaries of the American territories in the Pacific (American Samoa, Guam, and the Commonwealth of the Northern Mariana Islands) and of the former Trust Territories: the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau. The United States assisted with the formation of the judiciaries in these islands and the Pacific Islands Committee is charged with monitoring their judicial development. Traditionally, the courts of the Pacific administered justice with modest levels of resources.

The specific responsibilities of the Pacific Islands Committee include assisting in the development and provision of continuing judicial education and court professional training, and overall improvement of the administration of justice in the courts. The committee also has oversight responsibility for judicial education grants from the Department of the Interior which provide the funding for the training activities contained in this report.

The Pacific Islands Committee is composed of federal judges appointed by the chief judge of the Ninth Circuit. In FY 2019-2020, the membership included:

Overview of the Pacific Islands Judicial Education Program

The Department of the Interior appropriates funds each fiscal year to the Ninth Circuit to provide judicial training programs in the Pacific territories and Freely Associated States. This funding, which is mandated by Congress, covers the cost of presenter/staff travel, training materials and the travel costs of attendees for judicial education programs developed for the American territories and former territories in the Pacific. Each year, the Pacific Islands Committee of the Ninth Circuit Judicial Council provides Interior with a written report summarizing the programs and related expenses.

In Fiscal Year 2018, the courts of American Samoa, the Federated States of Micronesia, Guam, the Marshall Islands, the Northern Mariana Islands, and Palau participated in a wide variety of training programs designed to strengthen court governance and the rule of law, improve judicial systems and processes, and develop the skills of newly appointed judicial officers. The objectives of the training programs are as follows:

- The training of judges to provide fair, impartial, and speedy justice, with a bench imbued with integrity, professionalism and competence
- The training of court leaders with ethical principles to train court staff and lead courts in the 21st century
- The training of lawyers to provide a pool of qualified candidates to fill future judicial vacancies
- The training of court interpreters to provide access to justice to local communities
- The training of probation officers, court security officers, and other court personnel to effectively and efficiently administer access to justice

Program Development

The Pacific Islands Committee of the Ninth Judicial Circuit, which oversees the delivery of judicial training in these island jurisdictions, works closely with the Education Committee of the Pacific Judicial Council [PJC] to plan, develop, and deliver judicial training and court development services locally. In addition, the Committee works independently with the leadership of the judiciary of the Republic of the Marshall Islands to coordinate training consistent with the goals established by the judiciary's strategic plan and to provide scholarship opportunities to U.S. mainland trainings when those programs best serve the needs of the stakeholders. Compact Funds also support programs developed independently by the courts of the Federated States of Micronesia.

Target Audience

The assessment performed by the National Judicial College identifies the principal target audience for judicial training. This document, along with the FSM and RMI strategic plans, and the leadership of the judges who make up the PJC Education Committee, determine the training priorities each year. In fiscal year 2018, the highest educational needs have included practical training for probation officers, court administrators, and judicial officers. For judges, training focused on a wide variety of topics ranging from evidence, judicial writing, FAS/Territorial immigration issues, and attorney discipline.

Measuring the Impact of Judicial Training

Each program is evaluated to determine the impact of professional development on judicial (or staff) knowledge, beliefs/attitudes, and skills. Evaluation assures that the beneficiaries of this training have the knowledge and skills required to perform their judicial branch responsibilities with fairness and integrity. It preserves impartiality and access to the justice system; and ensures the administration of justice as well as public trust and confidence in the judicial branch.

For each program, ongoing evaluation is carried out to monitor cost efficiencies and evaluate program impact. To enable effective evaluation, precisely defined learning objectives are established for each program developed or attended by a funded participant. Careful evaluation of each program by participants is carried out and a summary reviewed by the program planning committee.

The effectiveness of the judicial education programs developed in FY 2014 in terms of learning gain, attitudinal or behavioral change, and improved professional conduct and performance was measured by a combination of the following:

- Participant satisfaction and self-evaluation forms
- Assessment of learning outcomes
- Reports written and submitted by scholarship recipients and program attendees
- A review of court annual reports.

2020 Programs at a Glance

In fiscal year 2020, ten judicial education projects were supported by funds from the Department of the Interior. The number of funded programs was greatly reduced from previous years because the COVID19 pandemic and related travel bans in place on many of the islands. Funding sources include the Technical Assistance Grant for judicial education awarded to the Ninth Circuit for training programs to benefit the judiciaries of American Samoa, Guam, the Northern Mariana Islands, and the Republic of Palau and Compact Funds for the Federated States of Micronesia (FSM) and the Republic of the Marshall Islands (RMI). 1. GENJR NJC General Jurisdiction

Dates: October 7-17, 2019

Location: Reno, NV

PROGRAM DESCRIPTION

The course introduced participants to a variety of subjects and skills they will need and use in their judicial careers. Both academic and experiential teaching techniques were used to provide them with the solid, basic understanding of various topics from ruling on evidence to handling the self-represented litigant. In addition to the substantive law sessions, participants learned about courtroom control, ethical pitfalls and solutions, effective communication techniques, and decision-making strategies. This nine-day course prepared new judges with the tools and resources to face most courtroom situations with confidence.

LEARNING OBJECTIVES

At the completion of the program, attendees were able to:

- Manage their courtroom and individual cases, including cases involving self-represented litigants
- Conduct jury and bench trials more effectively
- Make fair and unbiased decisions
- Communicate more effectively from the bench, using both verbal and nonverbal communication techniques
- Summarize and apply developments in criminal law and procedure, family law, judicial discretion, judicial ethics, and sentencing
- Rule on evidence more confidently
- Address electronically stored information issues

PROGRAM DESCRIPTION

This course focused on the court interpreter's role and ethics guidelines for court interpreters. The course allowed participants to practice skills in the areas of site translation, simultaneous translation, vocabulary building, and note taking skills. These practical activities were designed to encourage short term and long-term memory development. Such activities included learning to listen for meaning, memory exercises, shadowing, dual task training, paraphrasing, and sight translation.

Financial Management

The financial management functions of the Department of the Interior grants awarded to the Ninth Circuit are performed in accordance with the financial and travel policies of the U.S. Federal Courts with oversight provided by the Office of Financial Management of the Ninth Circuit office of the Circuit Executive.

Technical Assistance Grant

For fiscal year 2020, a Technical Assistance Grant of \$333,800 was awarded to assist the judiciaries of American Samoa, CNMI, Guam, and Palau. After subtracting administrative expenses, there was a total of \$239,944 available. Program expenses for fiscal year 2020 totaled \$110,333 leaving a balance of \$129,611 at the close of the fiscal year.

The expenditures for fiscal year 2020 were much less than anticipated due the cancellation of seven live trainings and several scholarships because of the COVID19 pandemic and related travel disruptions.

Section 105(i) of Public Law 108-188 established an annual program for the training of judges and court staff of the judiciaries in the Federated States of Micronesia and the Republic of the Marshall Islands in cooperation with the Pacific Islands Committee of the Ninth Circuit Judicial Council. The base amount of the program was established at \$300,000, an amount adjusted annually for inflation by Section 118 of the Compact of Free Association. The FY 2020 adjusted total was set at \$366,390. After subtracting administrative expenses, there was a total of \$313,100 available for education programs. Program expenses for FY 2020 Compact Funds for judicial education totaled \$135,035 leaving a balance of \$178,046 at the close of FY 2020.

The expenditures for fiscal year 2020 were much less than anticipated due the cancellation of seven live trainings and several scholarships because of the COVID19 pandemic and related travel disruptions.
